Pursuant to Article 107 and 108 of the Law on Public Procurement (RS Official Gazette, Nos 124/12, 14/2015 and 68/2015, hereinafter: LPP), Proposal of the Commission for Implementation of the Public Procurement Procedure OP: 06/2019 from the Report on Expert Evaluation of Bids no. 1162.5-19/JN of 15.08.2019, the person authorized to represent OPENS adopt the following

**DECISION ON CONTRACT AWARD
OP 06/2019**

In the open procedure for the public procurement of services – Organization of Street art festival, as per attached specification OP:06/2019, the Contract is awarded to the bidder **S.A.S Hurricane**, 3 Rue Christian Andre-Benoit, 34670 Baillargues-France, Registration No. 414 495 606 00058, Tax Id No: FR83 414 495 606.

The value of the public procurement contract is 50,000 euros, which, calculated in RSD using the official NBS middle exchange rate at the bid opening date 05 August 2019 (EUR 1 = RSD 117,7421), equals RSD 5.887.105,00.

EXPLANATORY MEMORANDUM

The open procedure for the public procurement of services – Organization of Street art festival, OP 06/2019, was initiated by the Decision on Initiating the Procurement Procedure (G. No 1162-19 /JN of 3 July 2019 (hereinafter: Decision).

The total estimated value of the public procurement defined in the Decision is RSD 6.666.667,00 exclusive of VAT.

The Committee established by the Decision G. No 1162.1-19/JN of 3 July 2019 (hereinafter: Committee), published the invitation to bid and the Tender Documents on 5 July 2019 on the Public Procurement Portal and the website of the OPENS (www.opens2019.rs) and the invitation was also published on the Portal of official gazettes of the Republic of Serbia and regulations databases.

The deadline for bid submission specified in the Tender Documents and the invitation to bid was 5th August 2019 by 09.00 a.m.

Within the deadline, 5th August 2019 by 09.00 a.m, a bid was received by the bidder:

S.A.S Hurricane, 3 Rue Christian Andre-Benoit, 34670 Baillargues-France, Registration No. 414 495 606 00058, Tax Id No: FR83 414 495 606, offering the total price of EUR 50.000, which at the NBS official middle exchange rate on the bid opening date, 5th August 2019 (EUR 1 = RSD 117,7421) amounts to RSD 5.887.105,00 exclusive of VAT.

During the evaluation and expert assessment of the bid by the bidder S.A.S Hurricane, 3 Rue Christian Andre-Benoit, 34670 Baillargues-France, the Committee concluded that the bid meets



all the requirements in the LPP and the Tender Documents, and therefore assessed it as acceptable.

Article 3, paragraph 1, item 32) of the LPP defines the appropriate bid as a bid which is timely and which fully meets all the requirements in the Technical Specification.

Article 3, paragraph 1, item 33) of the LPP defines the acceptable bid as a bid which is timely, not rejected by the contracting authority due to essential deficiencies, which is appropriate, which does not restrict or condition either the rights of the contracting authority or the obligations of the bidder, and which does not exceed the amount of the estimated value of the public procurement.

Article 107, paragraph 2 of the LPP stipulates that the contracting authority ranks acceptable bids by applying the contract award criteria defined in the invitation to bid and the Tender Documents.

Ranking was not carried out as only one bid was received and assessed as acceptable.

Article 107, paragraph 3 of the LPP prescribes that following the expert assessment of bids and based on the report of the Committee, the contracting authority makes the decision on awarding the contract, if it has received at least one acceptable bid.

Based on the review and expert assessment of the bid, conducted in accordance with the LPP and the Tender Documents, in its Report on the Expert Assessment of Bids, the Committee proposed that the contract in the public procurement procedure of services - Organization of Street art festival, OP 06/2019 be awarded to the bidder S.A.S Hurricane, 3 Rue Christian Andre-Benoit, 34670 Baillargues-France, Registration No. 414 495 606 00058, Tax Id No: FR83 414 495 606

In view of the above, the decision was made as stated in the main part of this Decision.

Legal remedy:

Against this decision the bidder may submit a request for the protection of rights to the contracting authority within 10 days of the day it is published on the Public Procurement Portal.
